<u>Updates on COVID-19 Restrictions in Wyoming</u> <u>Courthouses</u>

Per General Order No. 21-04, absent specific Court authorization all persons entering a Federal District of Wyoming Courthouse(s) located in areas of substantial or high transmission, as designated and defined by the CDC (https:// covid.cdc.gov/covid-datatracker/#county-view) shall be required to wear a face mas, whether fully vaccinated or not, while in any public areas of these facilities. including courtrooms.

Due to the fact that community levels are currently "low" or "medium," masking is no longer required in Cheyenne, Casper and Mammoth.

Nevertheless, should the community level reach "high" levels again, masking will be required once again until the levels return to "medium" or "low."

Please keep in mind that restrictions and requirements for Judicial Chambers shall be left to the discretion of the Judicial Officer, subject to the requirements imposed by any Federal Agency managing the common areas. U.S. Judicial Conference Celebrates 100th Anniversary

Over the last 100 years, the <u>Judicial Conference of</u> <u>the United States</u> has grappled with many issues: rising court caseloads and limited resources, natural disasters, public-health crises, and the safety of the Judiciary and the public. This year marks the centennial of the national policy-making body, which has helped ensure efficient administration of justice in the courts since 1922.

"The Judiciary's power to manage its internal affairs insulates courts from inappropriate political influence and is crucial to preserving public trust in its work as a separate and coequal branch of the government," Chief Justice John G. <u>Judiciary Releases Annual Report</u> <u>and Judicial Business 2021</u>

In 2021, the Judiciary confronted uniquely trying times: The global pandemic placed serious constraints on the courts for a second straight year, unanticipated spikes in caseloads were driven by the Jan. 6 upheaval at the Capitol and other events, and cybersecurity threats to government technology systems continued unabated.

Most importantly, in the face of trying times, we met our obligations under the Constitution as an independent and co-equal branch of government, just as the federal courts have done for more than two centuries," AO Director Mauskopf wrote in her introduction to <u>the report</u>.
