

UPDATED NOTICE REGARDING DISTRICT COURT CLERK'S OFFICE CHANGE IN OPERATIONS DUE TO COVID-19

As of May 11th, the Court reinstated public office hours to Monday–Friday 8:00 am — 12:00 noon and 1:00 pm - 5:00 pm. If you plan to visit any of our Court locations, please be advised of the changes noted below.



The District Court will resume in person hearings on Monday June 1, 2020.

Drop box locations in Casper and Cheyenne and the ability to use the new WydNewCase@wyd.uscourts.gov email address for filing pleadings will remain in place and continue to be monitored by Clerk's Office staff. The drop box will be checked throughout each business day until 4:00 pm. Documents deposited prior to 4:00 pm will be considered filed same day; documents deposited after 4:00 pm will be considered filed the next business day.

Payments can be accepted by check or money order by mail, by using the drop boxes or in person during public hours within 3 business days of submission of the new civil action.

RULE 84.2 <u>ADMISSION TO PRACTICE</u>; Please Note: You may submit all attorneys being admitted in one motion rather than filing separate motions.

NEXTGEN CM/ECF REMINDER:

NextGen CM/ECF features single sign-on functionality that give users access to both PACER and electronic filing from a single account. This update will require current e-filer registrants to upgrade their PACER accounts. You can click on the following link to login to PACER: https://pacer.psc.uscourts.gov/pscof/login.jsf. Once logged in, you'll want to go to the "Upgrade PACER Account" page of Manage My Account to complete the upgrade process.

CM/ECF TRAINING & PROCEDURES:

If you are an attorney wishing to file electronically in the District Court of Wyoming, please download the <u>REGISTRA-TION FORM</u> and call to schedule training with our Casper or Cheyenne offices. You must have a valid CM/ECF account to use this part of the system and these accounts are given only to active attorneys in the District of Wyoming. You can simply call the Help Desk Number at 307/433-2120 or 307/232-2620. CM/ECF training is offered once a month in Cheyenne, typically on the 3rd Wednesday, from 2:00 - 3:00 PM. Casper will continue to train new users as the need arises. Please call our office to reserve a seat!
