- ADHERE TO OUR CIVIL LOCAL RULES WHEN SUBMITTING NON-PUBLIC OR SEALED DOCUMENTS. WITHOUT PRIOR COURT AUTHORIZATION, NO CASE OR DOCUMENTS MAY BE FILED UNDER SEAL OR DESIGNATED AS NON-PUBLIC.
